- जिल्हा व सत्र न्यायालय, धुळे येथे जिल्हा सरकारी वकील व सरकारी अभियोक्ता या पदावर नव्याने नियुक्ती करण्यासाठी पात्र उमेदवारांकडून विहित नमुन्यातील अर्ज मागविण्यात येत आहेत.
2. उपरोक्त नियुक्ती निव्वळ तात्पुरत्या स्वरूपात करण्यात येतील व सदर नियुक्त्या दिवाणी प्रक्रिया संहिता, 1908 च्या आर्डर 27, फौजदारी संहिता, 1973 च्या कलम 24 (3) महाराष्ट्र विधि अधिकारी नियम, 1984 च्या नियम क्र. 11, 12, 13 व 30 मधील तरतुदीस अधीन राहतील. या नियुक्त्या कोणत्याही वेळी, कोणतीही पूर्वसूचना न देता संपुष्टात आणण्याचा अधिकार शासन राखून ठेवित आहे.
3. उपरोक्त पदावर नियुक्तीसाठी खालीलप्रमाणे पात्रता निश्चित करण्यात आलेली आहे. :-
- 1) अर्जदार भारताचा नागरीक असावा.
 - 2) अर्जदार कोणत्याही विद्यापीठाचा विधि पदवीधर असावा आणि त्यांनी बार कौन्सिल ऑफ महाराष्ट्र आणि गोवा यांचेकडे वकील म्हणून नोंदणी केलेली असावी.
 - 3) जाहिरातीच्या दिनांकास अर्जदाराचे वय 55 वर्षांपेक्षा अधिक असू नये.
 - 4) जे अर्जदार महाराष्ट्र विधि अधिकारी (नियुक्ती, सेवेच्या शर्ती व मानधन) (सुधारणा) नियम, 2017 च्या नियम अंमलात येण्याच्या दिनांकास किंवा तत्पूर्वी पासून सरकारी वकील किंवा सरकारी वकल व सरकारी अभियोक्ता किंवा सहाय्यक सरकारी वकील व अतिरिक्त सरकारी अभियोक्ता पदावर उच्च न्यायालयात किंवा जिल्हा सत्र न्यायालयात कार्यरत असतील. त्यांना उच्च वयोमर्यादेची अट 5 वर्षे शिथिल राहिल.
 - 5) जाहिरातीच्या दिनांकास अर्जदारास सर्वसाधारणतः जिल्हा व सत्र न्यायालयामध्ये वकीली व्यवसायाचा किमान 7 वर्षांचा अनुभव असणे आवश्यक आहे. अर्जदाराने जिल्हा व सत्र न्यायालयात वकीली व्यवसायाचा अनुभव धारण करित असल्याबाबत प्रमुख जिल्हा न्यायाधिश/प्रमुख न्यायाधिश/जिल्हा न्यायाधिश यांचे प्रमाणपत्र सादर करणे आवश्यक राहिल.

 - 2) विहित करण्यांत आलेल्या दिनांक व वेळेनंतर अर्ज स्विकारले जाणार नाहीत. अपूर्ण व अस्पष्ट अर्जांचा विचार केला जाणार नाही.
 - 3) अर्जदाराने अर्जासोबत आवश्यक त्या कागदपत्रांच्या / प्रमाणपत्रांच्या साक्षांकीत प्रती जोडणे आवश्यक आहे.
 - 4) नियुक्तीसाठी कोणत्याही उमेदवाराने कोणत्याही प्रकारे दबाव आणण्याचा प्रयत्न केल्यास उमेदवारास अपात्र ठरविले जाईल.

Applications are invited in prescribed form from eligible candidates for the appointment to the post of District Government Pleader and Public Prosecutor in District & Session Court, Dhule.

2. These appointments will be purely on temporary basis and terminable at any time without assigning any reason and subject to the provisions of order XXVII of the Code of Civil Procedure, 1908, (V of 1908), Section 24 (3) of the Code of Criminal Procedure, 1973 (II of 1974) and Rule 11, 12, 13 & 30 of the Maharashtra Law Officers (Appointment, Conditions of Service and Remuneration) Rules, 1984.

3. The required qualifications and eligibility criteria for the said posts as mentioned below :

1) Applicant must be a Citizen of India.

2) Applicant must hold a degree in Law from any recognized university and be enrolled as an Advocate with the Bar Council of Maharashtra and Goa.

3) Applicant must not be more than 55 years of age on the date of advertisement.

4) The Upper age limit of 55 years shall be relaxed upto 5 years in case of the person who, on or before the date of commencement of the Maharashtra Law Officers (Appointment, Conditions of Service & Remuneration) (Amendment) Rules, 2017 are appointed as the Government Pleaders or Government Pleaders & Public Prosecutors or Additional Government Pleaders and Additional Public Prosecutors in the High Court or District & Session Courts.

5) Applicant must have atleast 7 years of practice as an Advocate ordinarily in the District & Sessions Court, on the date of advertisement, certified by the Principal District Judge/Principal Judge/District Judge of the Court in which he practices.

4. The applicants who desire to apply for the above posts may submit the application in the prescribed form annexed herewith.

1) The applications should be addressed to the Collector and District Magistrate, District, Dhule and should be submitted during office hours on or before dated. 18/10/2017

2) The applications will not be accepted after the due date and time. The incomplete and illegible applications will not be considered as well.
